Rowing

There have been at least two outings every week on Tuesday evenings and 10 am Saturday/Sunday depending on weather. Instead of rowing to Trefor an extended picnic row happened. The yole has had several outings. Notable features on recent rows have been bioluminescence and seals.

Members attended a social evening at the Club – knotting featured! This topic to be explored again at our next social Club session.

Macsen has been mended by a professional boat builder at a cost of £200.00. Rowers have removed the barnacles and polished the hull. Elen will be turned over and worked on next. Proposal: allow purchase of gelcoat reviver (Marine Ploytrol £31.75) to cover two of the Celtics out of the budget of £250 as agreed previously towards the repair of Macsen, All in favour. At the request of Plas Menai our boats have been positioned within two spaces next to the container. Branwen is currently at ours prior to the taster session at PDSC in December.

Potential rowers: 4 have made contact via email – three have attended. Paul and Sally Dykins attended one taster session. Sian Williams has yet to attend. Hawys Williams has completed two taster sessions and sent in her application.

In addition, a £500 policy excess applies under the Marine hull section of the policy.
