10. Proposing New Members

- a) Pwhelli SC (CASC) have no proposer or seconder on their application form and do not ask for any additional info.
- b) Holyhead SC (CIC) follow the format of the RYA, their Constitution states new members must fill in an application form, does not state what is on the application form.
- c) Itchenor SC have 2 options, one with proposer and seconder if the new member has been known to them for 3 years+ or one applicable to others, new to the area and who do not know any members, which they complete online and are invited for interview.

TE said if the Constitution says new members must use an application form, we can still control what is on the form.

CNJ – modify the application form to ask what the NM can offer and what they hope to gain from the Club, in some cases a further chat with flag officers would be needed.

DH The application form online has been disabled to stop spam, therefore we must use the paper format.

KB There is no choice but to drop proposer and seconder so our application form must be modified.

6. Health & Safety Issues

Roof report showed that the base of the handrails on the roof, installed in 1960, were corroded. This needs addressing as part of main roof work.

7. Update on Incorporation

HMRC have granted us an extension until end of November to make CASC application.

Their requirements are:

- a) No exclusion of members on economic grounds.
- b) Members must be able to access equipment, no issue with rowing
- c) Guillemot Trust offers free sailing opportunities to anyone. TE to write to TE

EGM to be arranged to inform members of the proposed revision to the Constitution, 28 days notice required, Saturday at 2pm.

Draft for EGM to be circulated and feedback to be given by Committee.

8. Cannons

Malcolm Jones suggested a safety check be carried out on the Cannons as 2 guns are dated from the late 1800s. There are 2 gunsmiths in Bangor.

Regarding the issue of Port Dinorwic Town Regatta taking 2 cannons, due to an informal agreement. The question arises of whether they are out guns and does anyone at Port Dinorwic have a firearms licence. The informal agreement must stop.

CH Let them produce a firearms certificate as we need to know the names of people with a licence before we give away any cannons – shotgun certificate not enough.

CNJ Get all cannons serviced then choose the best.

TE to write to PDTR and clarify all unknown issues.

9. Training Centre

Training centre up and running with 5/6 students. John Summerfield has been offered a course at Rue Marina to observe a Yachtmaster course with RYA method of teaching. The course is free but accommodation and travel would amount to over £800.

The view was that the Club should not pay this as everyone has their own style of teaching following the RYA syllabus and other members have paid their own accommodation and travel for courses in the past.

11. Anton Waunfawr and CADW

Access and Operation of the Lift

A meeting was held and the insurance broker was present. The building is open to the public anyway, need to clarify the issue. Presentation to QW by Architect required.

12. Roof Report

TE/KB

In summary all three reports (1999, 2015 and 2023) state that the steel work is not up to standard.

- a) The loft access should be made safe for inspection, use of crawl boards.
- b) Ventilation system Control to reduce corrosion, these are in the kitchen but are not running and need an upgrade.
- c) Beams to be cleaned and painted with epoxy.
- d) Lateral supports mean only safe for 10 people on the roof not 50/60. If they fail it will be immediate, therefore needs addressing.
- e) TE to seek funding from Cadw.

13. Officer Succession

14. Membership MOJO

DH said a number of users have updated their details for the main member, there is no obvious way to link up the secondary member.

COMMODORES REPORT

The July experimental Zoom meeting coupled with a time limit appeared to improve attendance. Please feedback your comments.

Health and Safety.

Our gunners have suggested that a gunsmith should check our guns – the gunners require further investigation to determine, legal requirements, cost, and possible local gunsmiths.

Sea Cadets

Recent discussion with mark Walton suggests that Holyhead are willing to sponsor a new unit, but no imminent decision.

Incorporation.

The Secretary has incorporated the HMRC requirements into our current Constitution; an EGM at the end of October will be necessary to seek approval from members. The Commodore has adjusted the Articles and Bylaws. Extension of time to be requested from HMRC to end of October.

CADW/ Main Roof Structural Report.

A copy of the Structural Engineers report has been provided with the meeting agenda, the reports' executive summary succinctly highlights the issues with the roof beams and the work necessary to correct the problem, which was first highlighted in reports dated September 1999 and June 2015. We need to agree a course of remedial and management action to resolve the health and safety issues. It should not be allowed to drag on longer. CADW to be approached about funding.

Membership Questionnaire

First step towards an anonymous membership information gathering survey following RYA guidelines; a first draft has been prepared by the Vice Commodore, further work is required before it can be issued to the Management Committee for comments.

Female Toilet Refurbishment

Scope extent of work and specification- cost to be sort, delayed to September/ October. The final details will be dependent on the response to specific unisex toilet questions in the questionnaire.

Lift Extension and New Toilet Block

A meeting with CADW, WA and RWYC has been held to start the process of agreeing access, insurance, operation, and maintenance. Minuets of the meeting have been sent with the agenda. The Architect is to give a presentation of the project to AW. Insurance is an issue for AW.

Starting Cannons

During regattas, an informal arrangement allowing PDTR to borrow our guns became known — this has been going on for several years — there appear to be no formal records or clear recollections of the agreement! The critical issue is protecting our gunners Firearm licences, the choices are.

- The general recollection is that PDTR gave the guns to us because they had no firearms licence.
- Ask PDTR to produce a valid firearms certificate, endorsed with the cannon reference numbers, this would prove their ownership and identify the guns.
- If a valid certificate is not available, they must provide the name and address of the responsible person so we may advise the police of the transfer and have our certificates amended accordingly.
- We could simply deny them access by formally removing the informal agreement.
- A shotgun licence is not acceptable as a licence.
- We have eight guns and need six for regattas.

Training Centre Expenses.

John Summerfield has been invited by the company he did his RYA Instructor training with to attend, as an observer, a six-day RYA Yacht Master Offshore training course worth £400 plus vat, located at Rhu Marina, Scotland. The course is free; however, hotel, travel and sustenance costs are estimated at £890. Justification is exposure to current RYA teaching methods which would be of value to the development of our training. Are we willing to invest in our training by supporting John? te 27 August 2023.

Our sincere condolences to Sarah and Brian on the loss of Sarah's mum, we are all thinking about them and their family.

It is true to say that we have missed them- and with Kate and Elin also being ultra-busy at times we seem to be lacking direction, however Angie Laing, David Chinn, Ian and others have been

doing a great job of keeping some momentum and getting out to row Celtics and Yoles several times a month. Although numbers are currently low there is still a core to work with.

Out of the blue, Chris Kitt produced 7 super new young rowers who had the first of their taster sessions in the Celtics over the last 2 Tuesday nights and I am heartened to hear that they enjoyed themselves and that some are in the process of joining the club.

Perhaps the membership secretary could confirm who and when. I have seconded them all.

Their arrival did highlight some gaps in admin and shortage of coxing and coaching resources and whilst thanks to David and Angie we put up a safe and professional session, if we are to develop as a club we will need to increase the number of coaches.

Once I have found my feet and established contact with the right people then I will apply for grants for coaching courses and recruit/encourage some volunteers/victims to go on them. In my opinion only then can we move forward with more energetic recruitment of new rowers and start to re- develop the future of rowing at RWYC

We now have an agreement with PDSC that we can move a Celtic and 2 yoles there at the end of the sailing season until the start of the 24 season. They will be stored in the secure dinghy park by the slipway and we will have access to the clubhouse and facilities.

They have suggested £200 payable in advance which is a very fair rental as we paid £160 ish last year for one boat and for a shorter period. The rowers should easily be able cover this by pay as you row collections which I will oversee for now until Kates return.

Once I have your approval Steve Sinfield their treasurer will send an invoice. I would be grateful if it could be processed and paid.

2 Celtics will remain operational at Plas Menai and Uther is still at Brian and Sarah's.

David Chinn has applied to Sports Wales for a grant to 100% fund the £9k purchase of a training double scull boat-this has the approval of Sports Wales, Gwynedd County Council and Welsh Rowing-he has worked really hard to achieve this and the final application will go in once we have your approval.

For those of you who do not know him he is a British rowing coach whose speciality is rowing and coaching sculls- he has already encouraged us to make use of the Yoles which had been gathering dust in the container for years. David is a GP who lives in Waunfawr and has become an important and popular part of the club in a very short time.
