7. <u>EGM</u>

The amended Constitution has been sent round for comment and revision. There were no objections to putting it forward to the membership with 28 days notice. The EGM date was set at 28th October at 2pm.

11. Cash Register

Graeme's letter was sent in July and all to do with loading money onto a swipe card but we had previously agreed this was not going to happen. 12. Officer Succession

Treasurer

No volunteer for the job therefore Neil Christian, CCS Bangor, has offered to be Treasurer but we will have to pay for his firm's services at a cost of £4,800 inc VAT per year.

This resolves a number of issues. It would be much cheaper than paying for a bookkeeper / accountant / PAYE and we do need a Treasurer who is a member.

This maybe a conflict of interest but it would just need a sentence in the "Conflict of Interest" to advise membership.

Sailing Secretary

Sophie of Hortus has offered to do this but will need support in March when her baby is due.

Social Secretary

Linda intends to step down, a conversation with Julie Lewis is required to clarify if she is willing to take on the role.

13. Membership MOJO

DH looking at STRIPE as an alternative to Paypal.. This costs 1.5% plus 20p per transaction, this would save money.

Decision made to change to Stripe JC and KB to action.

14. Music Group Whats App

Meg Browning – improve attendance by Whats App. She will run and manage. KB to ask people in the Bulletin if they wish to join a group.

15. Insurance

KB needs the safety certificates, therefore electrical tests need to be done next month.

We have no insurance covering cash, now we have more people working behind the bar, is this necessary?

It was felt we should encourage a cashless bar to cover the safety of staff who would have otherwise to take money to the bank.

REAR COMMODORE

- 1. The indoor CCTV camera needs to be wired up. FS asked for a volunteer.
- 2. The rota for the bar is completed until December, however 9 days are not covered and an extra person is required to do a regular shift at the weekend.

SECRETARY

Once Stripe is set up members will be able to make online payments for: membership, ensigns, events, dinners, and regalia etc. The Stripe system will enable these payments to be made without incurring heavy transaction costs and will go straight into the bank account.

The usual payment systems will still be available.
